I had the pleasure of reviewing your application, and I have a few comments regarding additional items we will need leading up to the Planning Board on May 14.

- 1. All roof drains tied into the sewer must be removed
- 2. Are you still planning on including the playground as part of the project? You will need to submit information on the playground equipment as part of the permit application.
- 3. It appears that the public conservation easement area may be a little off from where the city believes it is. Let's check on this.
- 4. We will need to see turning radius movements for the fire apparatus. It is not clear that service vehicles will be able to make the required turning movements.
- 5. It appears that with the dumpster's placement, there is not a place to push snow. Please address this item.

Overall, I think we are getting closer, and this is ready to go to the planning board once we address these few items.
