**Subject**: American Rescue Plan Act (ARPA) Fund Update

**Information**: In May 2021 and May 2022, the City of Auburn received two American Rescue Plan Act (ARPA) fund allocations for a total award of \$13,545,799.00. As of June 3, 2024, the City Council has appropriated a total of 52 individual projects. To date, we have expended/encumbered \$13,237,572.63. A balance of \$308,226.37 remains.

Per ARPA Final Rule, <u>all funds must be obligated by December 31, 2024, or funds will need to be returned.</u> All remaining funds must be expended by December 31, 2026.

ARPA reporting mandates are extensive and require a tremendous amount of obligated documentation. It is important we meet the required deadline for reporting of December 31, 2024. To do this, we strongly recommend the city council approve the recommended reallocations. These projects have all the necessary obligated documentation to file with the federal government.

Staff projects recommended for consideration:

- Project #52 121 Mill Street Community Resource Center: Increase original allocation of \$438,702.83 by \$208,226.37 for total of \$646,929.20
- Project 23 Small Area Master Planning: Increase original allocation of \$300,000.00 by \$100,000 for total of \$400,000.00
