  - I. Zoe Miller opened this section by asking Committee members to share how they find out about community events and news and what they suggest for getting the word out. Suggestions shared:

II. Data collection and analysis – Eric Tang presented an overview of the data analysis thus far

- The two cites have provided thousands of crash reports
- Analyses are being refined based on feedback from the committee
- Fatal and serious injury crashes are concentrated in key corridors some of
- the most highly traveled corridors
- 126 crashes in the last ten years just in Auburn
- About 7% of crashes are fatal, serious, or minor (not sure if I heard this right)
- Under 1% of crashes involved pedestrians, .7% involved bicyclists
- Much greater likelihood of being killed or injured in these crashes
