

## **Facilities Systems Manager**

Primary responsibilities will include the management, coordination and overseeing compliance of all the operating systems with duties as follows:

- Managing and ensuring the efficiency of all School and City building automations systems included but not limited to HVAC, electrical, access control, security systems
- Conducting regular inspections, developing and implementing facility management policies and procedures to ensure efficient and safe operations;
- Plays a significant role in the development and planning of capital improvement projects;
- Evaluates historic and present energy consumption data; and applies forecasting and analytical techniques to calculate and project future energy costs for budgeting purposes;
- Negotiates energy contracts and manages the City's renewable energy portfolio;
- Conducts site visits and performs technical energy studies and audits of facilities to identify energy savings opportunities;
- Coordinating, overseeing, and/or assisting external vendors and contractors for facility capital and repair projects while maintaining contracts;
- Negotiating bids and contracts for third party workers;
- Troubleshooting and inspecting building issues;
- Collaborating with other departments to ensure that facility needs are met, and operational systems run smoothly;
